4. Birds can only be entered in one class.
5. Exhibitors are responsible for feeding and watering their own birds.
6. Pen numbers to be collected on day of Country Fest.

# Open Sheepdog Trials

**General Regulations**

1. The decision of the Judge shall on all points be final and, any competitor disobeying the Judge will be disqualified.
2. No dog except those competing will be allowed on the course.
3. Any dog or bitch that injures a sheep will be disqualified and the owner of such will be liable for damage.
4. All dogs entered must be the bona-fide property of the Exhibitor and, except when competing, must be held by a cord or a chain.
5. The name of each dog must be shown on the entry form.
6. No person will be allowed with the dog competing except the person working it and, he or she will stand where directed.
7. Judging will commence at 9.30am.
8. Running order will be as arrival on the field.
9. The Judge will decide as to the time the dogs will have allotted to do their work set out and, have the power to order-up as soon as they please any dog that commits a flagrant error.
10. Any bitch in season will run last in the respective trial.
11. Entrance fees for dogs not drawn or rejected for any reason before the Trial starts will be refunded.
12. No competitor is allowed to enter more than two (2) dogs on each day.
13. Entry fee is £5.00 per dog and includes 1 adult admission ticket to Country Fest. Exhibitors may purchase additional admission tickets at reduced rates on or before the closing date for entries. All fees include VAT.
14. Winner of each day's trial will be expected to Judge in 2019.
15. Admission ticket(s) will be despatched on or after Entry Close date of Tuesday 22 May 2018.
